JUDGES' CERTIFICATE OF MAIL BALLOT ELECTION RETURNS
FOR STRASBURG FIRE PROTECTION DISTRICT NO. 8

IT IS HEREBY CERTIFIED by the undersigned, who conducted the mail ballot election held in the Strasburg Fire Protection District No. 8, in Adams and Arapahoe Counties, Colorado, on the 8th day of May, 2012, that after qualifying by swearing and subscribing to their Oaths of Office, they opened the polls at 7:00 a.m., and that they kept the polls open continuously until the hour of 7:00 p.m. on such date, after which they counted the ballots cast for Directors of the District and for the ballot issue submitted in accordance with the Uniform Election Code.

STRASBURG FIRE PROTECTION DISTRICT NO. 8 BALLOT ISSUE A:

SHALL STRASBURG FIRE PROTECTION DISTRICT NO. 8 TAXES BE INCREASED \$128,822 ANNUALLY, OR BY SUCH AMOUNT AS MAY BE RAISED BY AN ADDITIONAL AD VALOREM PROPERTY TAX RATE OF 3.000 MILLS, TO PROVIDE FIRE, RESCUE, EMERGENCY MEDICAL AND OTHER EMERGENCY SERVICES, RESULTING IN A TOTAL DISTRICT MILL LEVY RATE EXCLUSIVE OF REFUNDS, ABATEMENTS OR DEBT SERVICE, NOT TO EXCEED 10.177 MILLS; AND SHALL THE DISTRICT BE AUTHORIZED TO COLLECT, RETAIN AND SPEND THE TAX REVENUE COLLECTED FROM SUCH TOTAL PROPERTY TAX RATE, AND ALL OTHER REVENUE RECEIVED FROM ANY SOURCE; COMMENCING WITH TAXES PAYABLE JANUARY 1, 2013, AND CONTINUING THEREAFTER; AS A VOTER-APPROVED REVENUE CHANGE, OFFSET AND EXCEPTION TO THE LIMITS WHICH WOULD OTHERWISE APPLY UNDER ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION (TABOR), OR ANY OTHER LAW, AND AS A PERMANENT WAIVER OF THE 5.5% LIMITATION UNDER SECTION 29-1-301, C.R.S.?
