BALLOT ISSUE 5A:

SHALL SUGARLOAF FIRE PROTECTION DISTRICT TAXES BE INCREASED BY \$75,000 ANNUALLY, AND BY WHATEVER ADDITIONAL AMOUNTS ARE RAISED THEREAFTER, BY AN ADDITIONAL MILL LEVY OF NOT MORE THAN 3.424 MILLS, (FOR A TOTAL GENERAL OPERATING MILL LEVY OF 7.000 MILLS) COMMENCING IN TAX YEAR 2012 FOR COLLECTION IN TAX YEAR 2013, WITH SUCH PROCEEDS TO BE USED TO SUSTAIN THE DISTRICT'S GENERAL OPERATIONS, SPECIFICALLY INCLUDING, BUT NOT LIMITED TO PURCHASE OF SUPPLIES, SERVICES AND EQUIPMENT, PURCHASE AND MAINTENANCE OF FACILITIES, TRAINING, IMPROVEMENT OF WATER SOURCES, AND ADMINISTRATIVE EXPENSES, AND SHALL SUCH TAX PROCEEDS BE COLLECTED AND SPENT BY THE DISTRICT AS A VOTER APPROVED REVENUE AND SPENDING CHANGES IN EACH YEAR, WITHOUT REGARD TO ANY SPENDING OR REVENUE LIMITATION CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION OR SECTION 29-1-301, COLORADO REVISED STATUTES?
