File a copy of this notice along with the resolution approving the cancellation, oaths of office, and a current faithful performance bond with the Division of Local Government @ 1313 Sherman St., Rm., 521, Denver CO 80203 no later than 30 days after the date of the regular election (No later than June 5, 2008). The board or DEO shall notify all candidates that the election was cancelled and they were elected by acclamation. The original notice is to be kept on file with the special district as part of the official election records.
