



PROCEDURAL INSTRUCTIONS: Publish (CRS 1-1-104(34) Publication defined) and post Notice of Cancellation to inform the electors of the district that the regular election has been cancelled. Post this document at all polling places, if applicable, and in the office of the Designated Election Official, as well as at the appropriate offices of the County Clerk and Recorder. File a copy of this notice along with the resolution approving the cancellation, oaths of office, and a current faithful performance bond with the Division of Local Government @ 1313 Sherman St., Rm., 521, Denver CO 80203 no later than 30 days after the date of the regular election (No later than June 5, 2008). The board or DEO shall notify all candidates that the election was cancelled and they were elected by acclamation. The original notice is to be kept on file with the special district as part of the official election records.
