

This form must be filed with the Division of Local Government within 30 days after the election and must be posted in the office of the DEO. The DEO shall notify the candidates of their election; after the oath and bond are filed, the DEO shall make and deliver a formal certificate to the elected directors.

**ORDER SETTING AN ELECTION ON THE ISSUE OF INCLUSION**

This matter having come before the court upon the Motion of the West Metro Fire Protection District for an order setting an election on the matter of inclusion of certain lands within the West Metro Fire Protection District, the court makes the following findings:

1. That on December 7, 2010 after proper notice was given as required by § 32-1-401(2)(b), C.R.S., the Board of Directors of the West Metro Fire Protection District adopted its resolution and order calling for inclusion of certain lands.
2. That no county or municipality filed any objection to the entry of such resolution.
3. That a copy of said resolution and order has been filed with the clerk of this court as an attachment to the Motion.

**NOW THEREFORE, PURSUANT TO § 32-1-401(2)(d), C.R.S., IT IS HEREBY ORDERED:**

1. That a special election on the matter of inclusion be held on Tuesday, February 8, 2011 on the issue of inclusion of the Ken Caryl Acres and West Fairview subdivision properties.
2. That the matter of inclusion shall be submitted to the qualified electors of the Ken Caryl Acres subdivision and West Fairview subdivision properties in accordance with Title 1, C.R.S., and that proper notice of the election be given by the secretary of the West Metro Fire Protection District in accordance with part 2 of article 5 of title 1, C.R.S.

3. That the ballot question shall be prepared by the designated election official of the West Metro Fire Protection District in substantially the following form:
