

**ADAMS COUNTY POST ELECTION AUDIT REPORT**  
FOR THE  
2014 COORDINATED GENERAL ELECTION  
November 4, 2014

---

The Adams County Post Election Audit was conducted on Monday, November 10, 2014. Canvass Board Members in attendance were: Dayna Wolfersberger, Lisa Mehrhoff, Gary Mikes, John Sampson, Veronica Gleaton, Karen Hoopes, Frances Mullins, Karen Goldman, Doug Woody, Marty Wisniewski, Patricia Moore, Sharon Richardson, Phil Ellsworth, Beverly Berg and Lynn Ann Sheats.

Adams County Elections staff present: Karen Long, Clerk & Recorder, Dena Abeyta, Elections Administrator, Eric Slovacek, Operations Manager and Jan Kuhnen.

The 2014 Coordinated General Post-Election Audit Report reflects approval signatures of the Canvass Board members: Phil Ellsworth, representing the American Constitution Party, Sharon Richardson, representing the Democratic Party, and Gary Mikes, representing the Republican Party. Additionally, Lynn Ann Sheats and Lisa Mehrhoff signed representing the coordinating entities. The Audit was also signed by the Adams County Clerk and Recorder, Karen Long. The day-long event resulted in the confirmation that the hand tallies of audited races equaled the totals recorded by the single Accu-Vote machine reviewed and the three DRE machines audited. The Board also confirmed that the DRE hash mark file signature and firmware version on the three tested DRE voting machines continue to be the version approved and installed by the Colorado Secretary of State's Office.

Details of the Audit include:

**INITIAL:** The Post-Election Audit conducted per 1-7-514 C. R. S., Election Rule 11 and the Conditions of Use for the Premier equipment began Monday morning, November 10, 2014 at 9:00 a.m. with an initial discussion of the process, basic housekeeping rules, selecting co-chairs and advising the Board which races and devices the Secretary of State randomly selected for the audit.

Gary Mikes, Phil Ellsworth and Marty Wisniewski were selected as chairs and observed each team, participating when needed.

Dayna Wolfersberger, Doug Woody and Lynn Ann Sheats made up team "A" and selected 325 ballots to hand tally and audit Central Count Accu-Vote-OS machine # 41069.

A separate Post Election Audit database for the Coordinated General Election was created and labeled Post Election Audit and a zero summary report run to ensure no votes were accumulated in the new database. Team A signed the zero summary report and ran their first batch through the Accu-Vote machine. A summary report was generated and the Team compared the totals to their hand tallied log. The machine totals and the hand tallies matched. A backup database was made of the first batch, the results were cleared and Team A repeated the process for each of the remaining batches.

Veronica Gleaton, Karen Hoopes, and Patricia Moore made up team "B" and audited DRE 274113. Team B located the printer canisters for the specific machine they were to audit (#274113), broke the seal on the container housing the election DRE print canisters and selected the needed canisters before re-sealing the container. The print canister seal was removed and recorded before unrolling the print canister's voter verified paper audit trail so that a hand tally of the votes cast could be conducted.

Frances Mullins, Beverly Berg and Karen Goldman made up team "C" that audited DRE 273010 Team C located the printer canisters for the specific machine they were to audit (#273010), broke the seal on the container housing the election DRE print canisters and selected the needed canister before re-sealing the container. The print canister seal was removed and recorded before unrolling the print canister's voter verified paper audit trail so that a hand tally of the votes cast could be conducted.

John Sampson, Sharon Richardson, and Lisa Mehrhoff made up team "D" and audited DRE 273087 Team D located the printer canisters for the specific machine they were to audit (#273087), broke the seal on the container housing the election DRE print canisters and selected the needed canister before re-sealing the container. The print canister seal was removed and recorded before unrolling the print canister's voter verified paper audit trail so that a hand tally of the votes cast could be conducted.

**INTERIM:**

Teams B, C, and D completed their audits of the DRE's and reviewed the DRE hash mark file signature and firmware version on the DRE's that were audited. Board members reviewed and signed a document for the machines, attesting that the DRE voting machine displayed.

Teams B, C and D were then issued a share of the remaining paper ballots and individual tally sheets to assist in the audit of the Accu-vote machine.

**FINAL:**

All four teams verified their hand tallies matched the summary from the machine totals. Team B, with the assistance of the co-chairs entered the results onto the 2014 Coordinated General Post Election Audit report and signed, along with Karen Long, Adams County Clerk & Recorder.

All paper ballots, tally sheets and forms used during the audit were placed in a container marked Post Election Audit, sealed and stored after completing the appropriate seal logs.

The Adams County Post Election Audit for the 2014 Coordinated General Election was thereby concluded shortly after 10:00 p.m. on Monday, November 10, 2014.
