

Post Election Audit

The post election audit for Clear Creek County was held on the 18th and 21st of November, 2016. The scanner chosen for auditing by the Secretary of State's office had scanned 4343 ballots during the course of the election. Canvass board members randomly selected 20 batches of 25 ballots each to audit. These 500 ballots were manually tallied by 3 bipartisan groups.

Batch reports from DVS were used to check the totals of the manual tallies. All vote totals matched, except for two that we found that were adjudication errors. With the new DVS system, we were able to look back in adjudication to see how the computer had counted the ballot. The two manual/machine counts that didn't match have an asterisk beside them on the report.
