Background of Pilot Election Review Committee

- In-Person Voter BMD-DRE Evaluation Form (Version 5, dated 7/30/2015), which is intended to solicit feedback about their voting experience from electors who vote in-person at a Voter Service and Polling Center, using the ballot marking or direct recording electronic voting devices of the piloted voting systems.
- County Evaluation Form (Version 2, dated 7/30/2015), which is intended to solicit feedback from election staff in the pilot election counties regarding their experience in using the piloted system to preparing for, conducting and canvassing the 2015 Coordinated Election.
