<p><b>MOTION TO VACATE</b></p>	

This matter is currently set for an administrative hearing on Monday, July 29, 2024. Because Respondent has not answered the Complaint or responded to the Complaint in any way formal or informal, the Division moves to vacate the hearing set for Monday, July 29, 2024. As good cause, the Division states:

1. The Division initiated this action by filing an Administrative Complaint on June 12, 2024. The Complaint alleged that Respondent, Ralene for D49, had violated Colorado campaign finance law by accepting prohibited contributions.

2. In the Complaint, the Division noted that the candidate for which the Committee was formed, Ginger Revord, had contacted the Division during

the early stages of its review of the original third-party complaint, in November 2023. Compl. ¶ 19.

3. However, the Division noted that subsequent attempts to communicate with the Committee or Record had been unsuccessful. *Id.* ¶ 21.

4. After the Administrative Complaint was filed, the Hearing Officer ordered the Committee to Answer or otherwise respond to the complaint on or before July 17, 2024. Order Setting Answer and Hearing Date at 1.

5. To date, Respondent has not filed an Answer, and the Division's attempts to contact Respondent have not been successful.

Accordingly, the Division respectfully requests that the Hearing Officer vacate the hearing set for Monday, July 29, 2024. The Division will continue its attempts to contact the Committee. If unsuccessful, the Division will initiate default proceedings.
