On October 16, 2024, the Elections Division of the Secretary of State filed a complaint against Fighting for a Stronger Colorado. The parties have agreed to a settlement in principle, and have submitted that settlement to the Deputy Secretary of State for his approval.

Because the parties anticipate that the settlement agreement will resolve this matter in full, the Division respectfully requests that the Hearing Officer stay proceedings in this matter pending finalization of the settlement agreement. Once the agreement is approved, the Division will move to dismiss these proceedings. If the parties are unable to finalize their agreement, the Division will move to lift the stay.
