AFFIDAVIT OF GARY ZIMMERMAN

COMES NOW the affiant, Gary Zimmerman, who, having been duly sworn and upon his oath, states as follows:

1. My name is Gary Zimmerman. I am over the age of eighteen (18) and am competent to testify in Colorado.
2. I am the Chief of Staff for the Colorado Secretary of State. I have held this position since early 2011. I am responsible for recommending any system or office policy changes to the Secretary of State.
3. Soon after I began work at the office of the Colorado Secretary of State, I became aware of a \$5000 discretionary fund provided to the Secretary of State. I discovered that it had been historically used, at the discretion of the then elected Secretaries of State, for furniture, office parties, county clerk receptions, clothes and bonus wages. I came to the understanding that these funds were available for use by the Secretary of State for public purposes as determined by the Secretary of State.
4. After I investigated the historic use of the discretionary funds by previous Colorado Secretaries of State, I discussed those funds with Secretary of State Scott Gessler. We discussed use of those funds to assist him in his role as Secretary of State.
5. In July, 2011, Secretary Gessler sought sums from the discretionary fund account for previously unreimbursed expenses. The request and the amount paid was \$1,400.00. This sum was consistent with our prior discussions as I was aware that Secretary Gessler had unreimbursed expenses for mileage and other expenses such as subscriptions and phone charges related to his role as Colorado Secretary of State.

6. In late 2011, I asked our staff to inquire of the State Controller's office concerning reporting on the discretionary fund for the Colorado Secretary of State and other elected officials. At that time, I was advised that no official policy or directive existed but that receipts or a memo from the elected official was advised to maintain documents to support the disbursements of discretionary funds even if it comes in the form of a memo from the Secretary of State.

7. In July, 2012, Secretary Gessler provided a request for the balance in the discretionary fund account which was \$117.99 and his letter in this regard met the advisory guideline as I understood it. Given that I was personally aware of unreimbursed expenses incurred by Secretary Gessler for mileage and other expenses which exceeded \$117.99, I did not question or object to the payment.

8. Only after July, 2012 did I begin work on a policy to recommend to Secretary Gessler as a guideline for use of the discretionary fund. That policy is not yet completed and has not yet been provided to Secretary Gessler for comment.

9. On August 24, 2012, I became aware of an email threat to Secretary Gessler and his family sent to an official state email address. I undertook an investigation of this egregious email threat. After discussing the matter internally, I decided to contact the Colorado Bureau of Investigation.

10. The matter was efficiently and properly investigated by the Colorado Bureau of Investigation. We soon learned that the email was sent by a New York resident. However, Secretary Gessler's family was relocated and given protection from the potential threat.

11. On August 29, 2012, I became aware of a voice mail which threatened the life of Secretary Gessler. It was from a local number. As a result, I was unsure if the threat came from the same person who sent the email threat. I discussed it with the Colorado Bureau of Investigation. I then discussed with Deputy Secretary Suzanne Staiert and other office staff. On my recommendation, we agreed Secretary Gessler should return to Colorado as soon as possible and the cost should be paid by the office of the Secretary of State. In so doing, I provided the Chief Financial Officer with an email authorizing the approved expenses.

12. Secretary Gessler returned to Colorado on August 31, 2012, at a cost of \$422.00.

AFFIDAVIT OF SUZANNE STAIERT

COMES NOW the affiant, Suzanne Staiert, who, having been duly sworn and upon her oath, states as follows:

1. My name is Suzanne Staiert. I am over the age of eighteen (18) and am competent to testify in Colorado.
2. I am an attorney licensed to practice law in the State of Colorado. I have been continuously licensed as a Colorado lawyer since 1993.
3. I have been the Deputy Secretary of State since February 29, 2012. Prior to serving as Deputy Secretary, I represented various local governments. From 1993 to 2006, I served as an Assistant City Attorney in Aurora. In this capacity, I advised elected officials and employees on the applicability of Title 24 reporting requirements and conflicts of interest. From 2006 to 2007, I served as a Municipal Court Judge in Aurora and Centennial. In 2007-2008 I served as an Assistant County Attorney in Arapahoe County. In 2008-2011, I served as the Littleton City Attorney. In this capacity I advised elected officials and employees on the applicability of Title 24 reporting requirements and conflicts of interest.
4. I am aware that historically the discretionary fund has been used for a variety of purposes.
5. I am familiar with C.R.S. § 24-9-105. I have reviewed the \$117.99 request and payment to Secretary of State Gessler in 2012. The \$117.99 payment reimburses him for otherwise non-reimbursed expenses such as mileage, phone charges and subscriptions, all of which help him perform his elected position of Secretary of State.

Good afternoon, Heather!

I have reviewed the CDOS Department Policy with respect to the Secretary of State Discretionary Fund. I have also discussed my response with the Deputy State Controller and the State Controller. The Office of the State Controller (OSC) does not endorse individual department policies. The OSC 's guidance to departments is that their policies must comply with statutes, fiscal rules, and IRS regulations, and should comply with OSC policies

In our judgment, the policy that you sent me to review is not in compliance with any of these items. Please review CRS 24-9-105, Title 24 Article 18, CRS 24-30-202; Fiscal Rules 1-8, 2-1, 5-1 (travel - section 9); and IRS Publications 15, 15B, and 463, which require documentation of reimbursable expenses.

After you have reviewed these documents, we would suggest that you revise the proposed policy so that it is in compliance with statutes, fiscal rules, OSC policies, and IRS regulations. Let us know if you need assistance in this effort.

As an alternative, the Secretary of State may choose to exercise the elected official exemption under CRS 24-2-102(4). In this case the Secretary of State would need to comply with Title 24 Article 18 and IRS regulations. This elected officials' exemption applies only to the Secretary of State and the Chief of Staff who can approve for the Secretary of State. The exemption is personal to those two positions, and cannot apply to the entire department. Under the elected official exemption, the Secretary of State and the Chief of Staff would be personally liable for any non-compliance with Title 24 Article 28 and IRS regulations .

Gary and Bill,

I spoke with the State Controller's Office and they gave me some information on how the discretionary fund has been used and how things have recently changed from a financial view. What I found out is this. In the past the discretionary fund, was used by "Elected Officials" in any way they wanted to use it. That is no longer the case. The state auditor's office is now, and has been, periodically auditing how the monies are spent from the discretionary fund. In the last couple of years, for the first time that I can recall, the auditors have asked about travel reimbursements made to the Secretary of State, as well as the use of the discretionary funds.

Therefore, the advice from the State Controller's Office regarding payments out of the discretionary fund was the following:

- All expenditures should have supporting documentation. (for example meal receipts etc...)
- A memo should only be written for reimbursement of expenditures incurred for "XYZ expenditures," or to justify expenditures for an event. (in other words no memo just for a blanket reimbursement).
- Expenses should be in "Pursuance of Official [State] Business" (not personal use)

The State Controller's Office advises that this is a departure from past practices because now state budgets are so tight that every department and Elected Officials' expenditures are being more closely scrutinized for statutory and rule compliance.

This information was new to me. Unlike fiscal or procurement rule updates, guidelines regarding other line item expenditures are not widely communicated. We basically find out when we ask a direct question. Now we know going forward how the fund is to be used.

I will be happy to discuss in more detail at our meeting Wednesday afternoon.

3. For approximately 13 years ending in February, 2012, I worked for the State of Colorado as the Deputy Secretary of State. As such, I worked with and advised Secretaries of State Donetta Davidson, Gigi Dennis, Mike Coffman, Bernie Buescher and Scott Gessler.
4. For two years immediate prior to becoming Deputy Secretary of State, I served as a budget analyst on the staff of the Joint Budget Committee of the Colorado General Assembly. In that capacity, I analyzed state budgets and programs and made recommendations to the Joint Budget Committee regarding appropriations to state agencies. In addition, for 16 years I served as an attorney in the General Assembly's Office of Legislative Legal Services, and for 12 of those years I was the lead legislative attorney advising the staff of the Joint Budget Committee on legal matters involving legislative appropriations to state agencies.
5. On one or more occasions after Secretary Gessler took office, I discussed with Secretary Gessler the discretionary fund provided to the Secretary of State pursuant to C.R.S. §24-9-105. In those discussions, I indicated that any sums appropriated by the legislature from the discretionary fund could be used for official business as the Secretary of State sees fit and by the complete discretion of the Secretary of State.
