



Notice of Proposed Rulemaking

Office of the Secretary of State Rules Concerning Campaign and Political Finance 8 CCR 1505-6

June 15, 2016

I. Hearing Notice

As required by the State Administrative Procedure Act,¹ the Secretary of State gives notice of proposed rulemaking. The hearing is scheduled for **July 26, 2016 from 9:00 a.m. - 11:00 a.m.** in the Aspen Conference Room on the 3rd floor of the Secretary of State's Office at 1700 Broadway, Denver, Colorado 80290.

II. Subject

The Secretary is considering a corrective amendment to the rules concerning campaign and political finance² to improve the administration and enforcement of Colorado campaign finance law.³

Specifically, the Secretary is considering rule revisions necessary to ensure proper administration of legislation recently passed by the Colorado General Assembly; establish uniformity in the administration of current law; eliminate obsolete provisions; remove rules stricken by the courts; remove references to repealed statutory provisions; simplify the language of existing rules; remove language that is duplicative of statute or constitutional provisions; and ensure consistency with Department rulemaking standards. The Secretary may consider additional rule amendments.

A detailed Statement of Basis, Purpose, and Specific Statutory Authority follows this notice and is incorporated by reference.

III. Rulemaking authority

The Secretary proposes the rule revisions and amendments in accordance with the following statutory and constitutional provisions:

Draft Statement of Basis, Purpose, and Specific Statutory Authority

Office of the Secretary of State Rules Concerning Campaign and Political Finance 8 CCR 1505-6

June 15, 2016

I. Basis and Purpose

This statement explains amendments to the Colorado Secretary of State rules concerning campaign and political finance.¹ The amendments are intended to ensure uniform and proper administration, implementation, and enforcement of Colorado campaign finance law² as follows:

- Amendments to Rule 1.1 to insert missing quotation mark.
- Amendments to Rule 1.3 to add small-scale issue committee in accordance with Senate Bill 16-186.
- Amendments to Rule 1.7 to add a filing schedule in accordance with House Bill 16-1282.
- Amendments to Rule 1.8.2 to correct a capitalization error.
- Amendments to Rule 2.2.4(b) to remove language that is duplicative of the Colorado Constitution and to maintain consistency with Campaign Finance Rule 10.6.
- New Rule 2.4.4 to establish procedures for filing of personal financial disclosures.
- Amendments to Rule 3.1 to add small-scale issue committees in accordance with Senate Bill 16-186.
- Repeal of Rule 4.1 as obsolete.
- New Rule 4.4 to ensure the proper administration of Senate Bill 16-186 regarding small-scale issue committees.

8 TIME.

9 *Amendments to Rule 8.1.3 concerning committee registration:*

10 8.1.3 An issue committee OR SMALL-SCALE ISSUE COMMITTEE must identify the ballot
11 measure it will support or oppose, if known. If particular ballot measures are not
12 known, the issue committee OR SMALL-SCALE ISSUE COMMITTEE must identify the
13 policy position it will support or oppose.

14 *Amendments to Rule 9.2 concerning resignation of the registered agent:*

15 9.2.1 A committee may assign a new registered agent by filing an amended committee
16 registration. FOR A CANDIDATE COMMITTEE, UPON RESIGNATION OF THE
17 REGISTERED AGENT THE CANDIDATE BECOMES THE REGISTERED AGENT UNTIL A
18 NEW AGENT IS ASSIGNED. FOR ALL OTHER COMMITTEES, THE A registered agent’s
19 name remains on file until the committee assigns a new registered agent.

20 *New Rule 9.3 concerning registered agent:*

21 9.3 IN THE CASE OF A CANDIDATE WHO IS THE REGISTERED AGENT FOR A CANDIDATE
22 COMMITTEE, IF THE SECRETARY OF STATE RECEIVES VERIFIABLE INFORMATION IN WRITING
23 THAT THE CANDIDATE IS DECEASED, THE SECRETARY OF STATE MAY IMMEDIATELY
24 TERMINATE THE CANDIDATE COMMITTEE IN TRACER.

25 *Amendments to Rules 10.2 and 10.3 concerning managing contributions and expenditures:*

26 10.2 Except for independent expenditure committees AND SMALL-SCALE ISSUE COMMITTEES,
27 committees must report contributions as follows:

29 10.3 Except for independent expenditure committees AND SMALL-SCALE ISSUE COMMITTEES,
30 committees must report expenditures as follows:

32 *Amendments to Rule 10.7.2 concerning contributions by anonymous contributor:*

1 10.7.2 Anonymous contributions are contributions where the identity of the contributor
2 OR OTHER REQUIRED REPORTING INFORMATION is unknown.

3 *Amendments to Rule 10.14.2 concerning other income:*

4 10.14.2 A committee must disclose all interest or dividends earned on its bank
5 account, earned income from a commercially reasonable transaction, or transfers
6 of money within a political party as other income on the committee's reports. ~~This~~
7 ~~"THESE other income" is~~ RECEIPTS ARE not subject to contribution limits.

8 *Amendments to Rules 11.2 through 11.4 concerning electioneering communications:*

9 11.2 Any person who expends \$1,000 or more per calendar year on electioneering
10 communication OR REGULAR BIENNIAL SCHOOL ELECTIONEERING COMMUNICATION must
11 include the method of communication on the electioneering report.

12 11.3 Persons making electioneering communications OR REGULAR BIENNIAL SCHOOL
13 ELECTIONEERING COMMUNICATIONS must maintain all financial records for 180 days after
14 the general election OR REGULAR BIENNIAL SCHOOL ELECTION, AS APPLICABLE. If a
15 complaint is filed against the person making electioneering communications OR REGULAR
16 BIENNIAL SCHOOL ELECTIONEERING COMMUNICATIONS, the person must maintain financial
17 records until final disposition of the complaint and any resulting litigation.

18 11.4 Electioneering communication reports must include the name of the candidate(s)
19 unambiguously referred to in the electioneering communication ~~in the electioneering~~
20 ~~report~~ OR REGULAR BIENNIAL SCHOOL ELECTIONEERING COMMUNICATION. [Colo. Const.

22 *Amendments to Rules 15.1 through 15.4 concerning recall elections:*

23 15.1 The recall election cycle begins on the date the recall petition is approved for circulation
24 by the designated election official and ends on the last day of the final reporting period
25 following the date of the recall election as defined in Rule 15.2.2.

26 15.1.1 If a recall petition is determined to be insufficient, the recall election cycle ends
27 ~~30-25~~ days after the time for protest and final disposition of any protest or appeal
28 of such determination.

29 15.1.2 If a recall election is canceled for any other reason, the recall election cycle ends
30 ~~30-25~~ days after the deadline for filing the recall election petition, or ~~30-25~~ days
31 after the event that caused the designated election official to cancel the election,
32 whichever is later.

33 15.1.3 If a recall election is canceled, ~~a committee that was~~ ALL COMMITTEES THAT WERE
34 participating in the recall election EXCEPT SMALL-SCALE ISSUE COMMITTEES must
35 file a report five days after the end of the recall election cycle. The ~~end of cycle~~
36 ~~begins~~ REPORTING PERIOD BEGINS on the first day ~~of the month in which the~~
37 ~~election cycle ends and~~ FOLLOWING THE LAST DAY OF THE REPORTING PERIOD FOR

7 15.2.1 The initial reporting period for committees formed for the purpose of the recall
8 election begins on the date the committee registers with the appropriate filing
9 office.

10 15.2.2 Subsequent reporting periods for a committee participating in the recall election
11 begin on the first day of each month and end on the last day of that month, except
12 that the final reporting period ends 25 days following the date the recall election
13 was held.

14 15.2.3 All other committees ~~participating in the recall election~~—WHOSE ORIGINAL
15 FORMATION WAS NOT FOR THE PURPOSE OF SUPPORTING OR OPPOSING A RECALL
16 MEASURE must notify the appropriate officer within ten days after deciding ~~they~~
17 ~~will~~ TO support or oppose ~~the~~ A recall or support or oppose a successor candidate.
18 Once notified, the appropriate officer will place the committee on the recall filing
19 calendar until the end of the recall election cycle.

20 15.3 The incumbent in a recall election is not a candidate for the successor election and may
21 open an issue committee OR SMALL-SCALE ISSUE COMMITTEE to oppose the recall.

22 15.4 The aggregate contribution limits specified for a general election in Colo. Const. Article
23 XXVIII, Section 3, AS ADJUSTED BY THESE RULES, apply to the recall election with
24 respect to each successor candidate.

25 *Amendments to Rule 17.1 concerning filing calendars and reporting periods:*

26 17.1 A committee other than a political organization OR SMALL-SCALE ISSUE COMMITTEE must
27 file a disclosure report for every reporting period, even if the committee has no activity to
28 report during the reporting period.

29 *Amendments to Rule 17.2.2 concerning filing schedules:*

30 17.2.2 A political committee, small donor committee, political party, independent
31 expenditure committee, or political organization files on:

32 (a) A frequent filing schedule during any year in which a general election
33 occurs AND, IF PARTICIPATING IN A REGULAR BIENNIAL SCHOOL ELECTION,
34 IN ANY YEAR IN WHICH A BIENNIAL SCHOOL ELECTION OCCURS.

- 1 (b) An infrequent filing schedule during any year in which no general election
2 occurs, EXCEPT IF THE COMMITTEE IS PARTICIPATING IN A REGULAR
3 BIENNIAL SCHOOL ELECTION.
