Rules I don't and why:

- 6.1.1 is this not in conflict with C.R.S. 1-6-104 and 1-6-103.5? An election judge shall serve for a two year period and the political party in even numbered years.
- 6.1.3 By the 60th day most of us have already contacted judges and have them in their assigned areas- again doesn't this conflict with C.R.S 1-6-104 and 1-6-103.5?
- 6.1.4 What is the purpose of this rule to provide a list back to the parties?
- 6.3 I can see us not doing the initial but we should have a say in the final rejection because we are the one that ultimately will have to defend ourselves in court for what our judges are or are not doing.
- 6.4 This should be more than 5,000 to be able to use staff – our staff is going to have to help run SCORE and the process so why can't one of the signature judges be a staff member? Not all of us have a room full of people performing the signature verification and not all of us can afford to pay to have extra judges just hanging out waiting to do a second signature verification.
- 7.2.8 What is the purpose of this rule? The electors name is already on the return envelope in the return area? Why does it need to be near the self-affirmation area? This is going to be tough for some vendors because of how they spray the address on the return envelope so they would need to make an additional pass through the machines with the envelopes and we are just asking for error's doing this?
- 7.8.1 So which party gets this if you only have one person doing the verification?
- 7.8.7 BI Partisan I assume would be Rep/Dem? Can this second person be (1) staff of the opposite party that is on 7.8.1?
- 7.8.8 What guide do we have to audit this? Is the state going to have a % for us to follow or some guide lines?
- 8.1.5 How will we know they have completed a training from the SOS for this?
- 8.7 Will this be a fillable form that the SOS provides? And are we just speculating since it is 90 days out from an election?
- 8.13 why can watchers escalate ballots for signature discrepancy? What happened to not interfering with the election process? Is this not in conflict with 8.15.1 and 8.15.4?
- 8.16 Is this not in conflict with 8.15.1 and 8.15.4?
