**In regard to SB21-250 SECTION 6.** In Colorado Revised Statutes, 1-2-213.5, add (1)(c) as follows: 1-2-213.5. State institutions of higher education - electronic voter registration option - information to students. (1) (c) EACH STATE INSTITUTION OF HIGHER EDUCATION SUBJECT TO SUBSECTION (1)(a) OF THIS SECTION SHALL, DURING THE FIRST FULL WEEK OF EACH FALL SEMESTER AND DURING THE LAST FULL WEEK OF EACH SPRING SEMESTER, PROVIDE BY E-MAIL TO EACH ENROLLED STUDENT INFORMATION ON VOTER ELIGIBILITY AND ON HOW TO REGISTER TO VOTE OR UPDATE THEIR VOTER REGISTRATION INFORMATION IN THE STATEWIDE VOTER REGISTRATION DATABASE

We support the recommendation of the Colorado Elections Youth Advisory Council and recommend the adoption of the following template for the required student election notification. We recommend that notifications use this template or include the information outlined in this template in another format.

## **Colorado Election Information - Student Notice**

Students may choose to vote at their campus residence as long as they have been a Colorado resident for at least 28 days, or students can choose to vote in their home state or city.

When a student registers as a Colorado voter, this cancels any previous registration in another state.

Colorado has no deadline for voter registration. Students can register and immediately cast their ballot through election day.

## **September Notification** Election and Voting Information

**For each election** taking place during the academic year (September 1 – May 30 of the following year), the notification will include:

- **Election Title, Day of week, Date**  
Ex: General Election, Tuesday November 3, 2020  
Ex: Colorado Primary Election, Tuesday June 30, 2020
- **List of Federal, state and local positions included in the election.**

**May Notification** Election and Voting Information The same information will be provided for each election taking place during the **summer break (May 15 – September 1)**, the notification will include:

**Mail Ballot Information**  
If you are registered by **DATE** (eight days before election day), you will automatically receive your ballot by mail.  
Ballots should be received by **DATE**.  
If you registered after the mail cut-off or have not received your mail ballot by this date, contact your [County Clerk & Recorder](#), where you will also find a list of county Voter Service & Polling Centers.

Mail ballots can be returned

- via U.S. Postal Service (be sure to put a stamp on the envelope)
- by dropping off the ballot at a Voter Service or Polling location. Contact your [County Clerk & Recorder](#) for polling locations.
- By dropping the ballot into a drop box. Contact your [County Clerk & Recorder](#) for drop box locations.

### **Early Voting**

Colorado voters can vote at a Voter Service & Polling Center starting **DATE** through **DATE, HOURS**.
